All,

I met with AMP-Ohio on another matter this morning and Jolene Thompson outlined what they are looking for from the state.

- 1) Assistance with property acquisition costs (currently at \$18 million); They previously applied for \$5 million from JRS program under Taft Administration and were denied. This is their number 1 request from ODOD.
- 2) Low-interest interim financing during construction – could get OAQDA and AMP-OH Bond counsel together to discuss options. (Todd Nein is aware of this.)
- 3) Help with workforce issues and work supports during project construction – this can be applied to all of the projects in the area. (spoke briefly with Mary Benedict on this).
